

Airport's (Protection of Airspace) Regulations 2026

Application to undertake a controlled activity into prescribed airspace

This form should be used to apply to undertake a controlled activity into Melbourne Airport's prescribed airspace, made pursuant to **section 12** of the Regulations.

To ensure a prompt review, please ensure that your submission is accurate and complete. Incomplete submissions may result in a delay to the application process.

Paragraph 12(3)(a) of the Regulations states that an application must be accompanied by a copy of an assessment by Airservices, in relation to the activity, obtained by the airport. An application is generally not complete until an Airservices assessment has been provided. This process can take up to approximately 6 weeks depending on the level of complexity and agency workload.

Compliance

Carrying out a controlled activity other than in accordance with an approval that has been granted under the Regulations is an offence under Part 12 of the Airports Act 1996 (Cth). A copy of the department's Airspace Protection Compliance Framework is available via [Airspace Protection at Leased Federal Airports](#).

Providing false or misleading statements in applications or false or misleading information or documents may constitute an offence against Part 7.4 of the Criminal Code Act 1995 (Cth).
