

#### Melbourne Airport PSP Key Definitions

The Melbourne Airport Parking Signage Plan (this document) details the Landside Vehicle Parking Restrictions applicable to the entire Melbourne Aiport precinct, in accordance with Commonwealth consolidated regulations of the Airport (Control of On-Airport Activities) Regulations 1997, Pog 106BA. The restrictions outlined herein are applicable to all public and private vehicles, including moto cycles. Please review for designated locations as detailed below and outlined in the Key for each individual map drawing. The colours on the left indicate areas which are the subject of parking control devices. NO STOPPING AREA All roads within Melbourne Airport Precincts (see Drawing 1.0) are NO STOPPING areas except where signed. 








